CONDITIONS OF REGISTRATION

1. Parents may make an application for their child to be enrolled in either senior school.
2. There must be sufficient space to accommodate the student as per the permissible maximum enrolment.
3. Where the number of registration applications for a particular senior school exceeds the permissible maximum enrolment, the successful applicants shall be randomly selected.
4. Students who require a Learning Support Program may not be placed at their first choice senior school if the program is oversubscribed. In these cases students will be randomly selected.

PROCEDURES FOR REGISTRATION

3. Please ensure that the form is completed correctly. Incomplete and/or incorrectly completed forms may result in a delay in registration and may impact the admission of your child to a particular school.
4. Please submit the completed registration form to the Department of Education on Tuesday January 15th, Wednesday January 16th, or Thursday January 17th, 2019.
5. Any applications received after the registration deadline will be deemed late, and only considered after all on-time applications have been processed.
