## **Background**

In 2021, following an extensive consultation process, the Minister of Education ("the Minister") decided to transition ten primary schools into parish primary school sites and close the remaining primary school sites.

#### PARISH PRIMARY SCHOOL DECISIONS - JULY 2021

The Decisions by Parish, Primary School Site and Location Site

It was decided that the following school sites would be established as parish primary schools.

It was also decided that the following school sites would be closed as public primary schools.

Comprehensive criteria were developed to support the vision for parish primary schools and used to score each of the then 18 primary school sites to determine which ones should be redeveloped to become parish primary schools and which sites should close permanently. The broad study factors used by a team of technical officers (called the 'School Location Strategy Team') were: Existing Building Conditions; Land/Property Conditions; Safety & Health; and Transportation.

During and after the consultation process, school-community members, especially alumni, raised concerns about the lack of inclusion of History and Legacy as a broad study factor. They also had a number of other issues with the scoring process. After a

series of meetings with stakeholder groups, in July 2023 the Minister announced that there would be a (re)scoring process using the broad study factor of 'history and legacy.'

The Minister asked the History and Legacy Working Group (HLWG), to design and recommend History and Legacy study factors that could be used for the new scoring process. Following the HLWG's submission, staff of the Ministry of Education Headquarters reviewed and adapted the recommended History and Legacy study factors.

The Ministry engaged a Scoring Team to conduct an assessment to rate the history and legacy category. The following primary schools were scored using study factors for History and Legacy:

- i. East End Primary School
- ii. St. George's Preparatory School
- iii. St. David's Primary School
- iv. Victor Scott Primary School
- v. West Pembroke Primary
- vi. Northlands Primary School
- vii. Paget Primary School
- viii. Gilbert Institute
- ix. Dalton E Tucker Primary School
- x. Port Royal Primary School
- xi. Somerset Primary School
- xii. West End Primary School

# **Summary of the Scoring Process**

The Scoring Team consisted of four (4) government technical officers:

- i. Permanent Secretary, Ministry of Education Assessor
- ii. Director, Department of Community and Cultural Affairs Assessor
- iii. Acting Archivist, Department of Archives Assessor
- iv. Policy Analyst, Ministry of Home Affairs Compliance

Each identified primary school was invited to select three (3) persons to represent the school. These persons served as the school community representatives for each primary school that participated in the process.

Through communications with school principals, school community representatives were invited to attend online meetings of one hour duration, hosted by the Scoring Team, where school community representatives presented information on the History and Legacy study factors that they received in advance of the meeting.

The meetings were held 26, 27, and 28 March 2024. The meetings were recorded and the recordings serve as a record of each meeting. These recording are available here:

During these meetings, the school community representatives were advised that they would have up to three days to send follow up information for the consideration of the Scoring Team. Written submissions were received from seven schools: Port Royal Primary School, Paget Primary School, East End Primary School, Victor Scott Primary School, St. David's Primary School, St. George's Preparatory School, and West End Primary School.

The Scoring Team reviewed, considered, analysed and assessed the submissions and information and determined a score of 0 to 5 for a maximum rating of 60 points.

The Scoring Team considered the information holistically, and scored each identified primary school using the following rubric:

# **Revisions to the Original School Location Strategy Team Ratings**

#### REVISION OF ORIGINAL SCHOOL LOCATION STRATEGY TEAM RATINGS

In response to questions and critiques regarding the original scoring process and certain scores, the individual ratings of the School Location Strategy Team were scrutinized and revisited by the Ministry (after meeting with members of the original School Location Team to discuss their findings). This process resulted in the following changes:

#### AGE OF THE BUILDING

The Somerset Primary School building was built in 1960. The original score included a rating of 4 points. The score was revised to reflect the rating of 3 as the school building would have been 61 years old at the time of the assessment in 2021.

# **EXISTING LAND AREA (Usable/Zoning)**

The Somerset Primary School can accommodate 330 students and has a large field that can accommodate different age groups, but may not be able to accommodate additional parking or it might be able to accommodate some areas for separate playing areas and some additional parking, but it may not be adequate. Therefore, it would not qualify for a rating of 5. The West End Primary School building site's score included two ratings of 1. It was determined that the rating value for the school would be a minimum of rating 2 since there is land to create some parking and some playing fields for different age groups.

### **BOUNDARIES AND COMMUNITY CENTERED**

The Somerset Primary building site included 1 score of 5. There are restrictions to the boundary – there is a main road on two boundaries, the preschool on one boundary and residences on the fourth boundary. Therefore, the site did not meet the 5 point rating. The West End Primary School's building site's score included five ratings of 1. It was determined that the rating value for the school would be a minimum of a rating 3 since there are some restrictions to the boundaries, but the land can be developed.

#### **COMMUNITY SERVICES**

An assessment was conducted on the community services in and around all of the schools that were assessed and it was determined that two businesses on Scott's Hill Road, Sandys, Bailey's Enterprises and Trojaniers Barber Shop, are in immediate proximity to the West End Primary School qualifying it for a higher rating. Also, none of the schools in the Sandys parish would qualify for the highest rating of 5 points. Therefore, the ratings were adjusted as none of the school buildings are located *directly within a community with surrounding services such as a supermarket, gas station, church building, residential area, etc.* 

#### Revision:

Somerset Primary: Original score 24. Revised score 21. West End Primary: Original score 15. Revised score 18.

# TYPE OF ROAD - estate / main public

Both Somerset Primary School and West End Primary School received ratings of 1 and 5. It was determined that none of the schools have access to get on the school campus through an estate road and as such rating 3 is more appropriate. Somerset Primary School has more than one access road. However, access is limited by the type of vehicle because the roads are very narrow without access to free flow of traffic when vehicles have to pass.

#### Revision:

Somerset Primary: Original score 21. Revised score 17.

West End Primary: Original score 17. The score did not change because a rating 5

was revised to rating 3 and a rating 1 was revised to a rating 3 for a net 17.

#### CLARIFICATION OF FLOOD RISKS and ACCESSIBILITY

#### FLOOD RISKS

Some schools were of the view that the Flood Risk study factor was aligned with flooding due to global warming and rising tides. However, the study factor relates to flooding on the school property due to drainage of water; especially after heavy rainfall or during storms.

### **ACCESSIBILITY**

Stakeholder feedback indicated the common misunderstanding that accessibility related to access to the school property only. In this context, accessibility related to wheelchair accessibility for students with mobility related disabilities so that they could easily navigate through and onto the school property and for a separate entrance to the school for student drop-off and pick up. This study factor came directly from the **2015 SCORE Advisory Committee Report**.

Both of these study factors have been clarified as:

Flood Risks (Flooding due to drainage in areas)

Accessibility (Wheel chair accessible to accommodate students with disabilities. Separate entrance for drop off and pick up).

## **Effect on the History and Legacy Assessment on Total Scores**

The final overall weighted total scores of all of the study factors, including History and Legacy are:

## St. David's Primary Decision

After the final re(scoring) process, there were additional discussions that emphasized the distinctive nature of the St. David's community compared to the rest of St. George's Parish. The final History and Legacy Score of St. David's Primary School (at 57) reflected and underscored this area's unique character and rich history.

Therefore, due to the unique characteristics and history of the St. David's community compared to the rest of St. George's Parish, it became clear that St. David's Primary was distinct, which deserved recognition. The school's impressive History and Legacy Score was a key indicator of its unique cultural and community significance. Consequently, the Minister decided to redevelop the St. David's Primary School site into a second Parish Primary School for St. George's Parish.
